Funds established in 2011:

Donor Advised Funds:

Don and Betty Fleming Family Charitable Fund was established to support area non-profits as advised by the donors.

Michael Kirkbride Memorial Fund was established to honor the memory of Michael Kirkbride. The family will make charitable gifts to causes that were important to Michael.

Mt. Moriah 506 Order of the Eastern Star Fund was established to support charitable work in our community as advised by the membership of the Order.

Agency Funds:

Harmar Community Center Fund was established to provide funding and support to the Harmar Community Center.

Chavez Run for Charity Fund was established to support military families or families with special needs in having an opportunity to have a family vacation.

Friends of Felines Fund was established in 2011 to support the Spay and Neuter of cats & kittens in the Washington County area.

Teri Ann's 50th Anniversary Fund for Women was established in honor of Teri Ann's 50th anniversary and will support organizations and causes dealing with women's health.


