TO RETURN TO THIS FOUNDATION AFTER AN ABSENCE OF MORE THAN 10 YEARS HAS BEEN A REAWAKENING I SHAN'T SOON FORGET.

It has served to remind me just how far forward the Foundation has migrated since Bob Kirkbride asked me to become a Board member well back in the 1990s while I was still serving as Vice President at Marietta College.

During my initial tenure, in 1995 we opened an office and hired our first Executive Director, Connie Struebing, a mature and talented MC grad. Carol Wharff succeeded Connie in 1998 through the summer of 2002 followed by Bret Bicoy, then Jack Moberg and the Foundation's growth continued unabated.

As its assets grew, so did the Foundation's impact on the community of Marietta and the surrounding area. Grants to our neighbors on the other side of the Ohio River helped build a shelter in the community park, and additional grants are helping build a new pool.

Grants have helped the museum in New Matamoras, the library in Sardis, and community foundations in Noble and Meigs Counties have their funds invested with the Marietta Community Foundation.

This is not to mention the more than 350 grants to various agencies, organizations and individuals over the years meeting a myriad of needs put forth during the Foundation's regular grant cycles each year. The grants awarded ranged in number from six in 1992 to 45 in 2006 and in amounts from \$46.19 to \$125,000.

In earlier years the Foundation helped get hot lunches back into the city's schools, and its launching of 20/20 helped focus attention on improvements in Marietta.

Now the Foundation needs to again look closely at what it might do to assist in turning around the city's population losses by helping attract young people and new businesses. Interestingly they must be attracted to a city already named by AARP as one of Ohio's three best retirement communities!

Challenges (other than floods!) exist at the confluence of the Ohio and Muskingum Rivers, and the Marietta Community Foundation stands ready to help meet them.

FROM THE DESK OF THE FOUNDATION

OUR FOUNDATION HISTORY

Marietta Community Foundation was founded in 1974 as community leaders, headed by the late Carl L. Broughton, planned for Restoration '76. Upon completion of Restoration '76, Marietta Community Foundation lay relatively dormant 16 years before being reactivated in 1992 through a sizable gift from two former Marietta residents, Mary Carolyn McCoy Mildren and William E. Mildren Sr., of Vienna, West Virginia. They established a trust in memory of their late parents. Simultaneously, a new Board of Governors, headed by Chair Robert Kirkbride, was formed.

In 1995, the revitalized Marietta Community Foundation received a major bequest of \$2.4 million from the late Lillian Strecker Smith. The J. Frank and Lillian S. Smith gift was unrestricted, but with a strong directive that the Foundation pay special attention to the needs of the elderly in the community, St. Mary's Catholic Parish and Marietta College. Today Marietta Community Foundation has grown to more than \$10 million in assets and has dozens of funds.

THIRTY-ONE NEW FUNDS WERE ESTABLISHED *during 2007. More and more, thoughtful and generous individuals and non-profit organizations are realizing (1) how easily a fund can be established; (2) how the fund, with good management, can grow; (3) how the Foundation handles all paperwork at no cost to the donor, and (4) that there can be significant tax advantages.*

UNRESTRICTED FUNDS

Donors place no restrictions on how these funds are to be used, giving the Foundation the greatest flexibility in making grants to address the community's most pressing needs. The Foundation offers competitive grants three times a year, enabled by generous gifts from the community. Marietta Community Foundation includes all general and memorial contributions in its portfolio of unrestricted funds.

BRET & CARI BICOY FAMILY FUND

Bret & Cari Bicoy, with their children Alyssa, David, Bret Jr., Kekoa, Nalani and Malia, established the Bret & Cari Bicoy Family Fund in 2004 to celebrate the wonderful years they spent living in Marietta, Ohio.

FIELD OF INTEREST FUNDS

The donor directs the Foundation to support an area of choice; e.g., arts, education, health or recreation. The Foundation awards grants to organizations within the specified field.

WILLIAM E. MCKINNEY MEMORIAL TREE FUND

Established in memory of William E. McKinney, former publisher of The Marietta Times, to support the planting and continued care of trees for beautification of the city.

SARAH REBECCA WARREN FUND

Provides medical assistance for individuals in financial need who are referred by a nonprofit agency. Recipients are uninsured and underinsured residents of Marietta Township or reside within the Marietta city limits.

DONOR ADVISED FUNDS

Many donors maintain an active interest in the Foundation by participating in a grant-making process. Donor Advised Funds encourage donors to offer suggestions for distributions to different charities. This fund type is especially useful for donors who want to take a charitable deduction one year and make distributions from the income or principal over several years.

Established by his family and friends to honor John's lifelong commitment to providing opportunities for the children of our community.

MCKINNEY SCHOLARSHIP FUND

Awarded to a Marietta High school graduate pursuing a career in journalism.

THE JOSEPH AND BARBARA MEEK SCHOLARSHIP FUND

Established to provide funds for students from Warren Local School District area or such successor district to attend college who might not otherwise be able to attend.

J. WILLIAM MORRIS SCHOLARSHIP FUND

To provide a scholarship fund in honor of J. William Morris, husband of F. Isabel Morris.

COACH HANK MORUS ATHLETIC SCHOLARSHIP FUND

Established in October 1998 by interested community citizens who knew and worked with Coach Hank Morus to honor his memory for his years of service as teacher, coach and athletic director in the Frontier Local School District.

WARREN E. OFFENBERGER SCHOLARSHIP

Awarded to a Marietta High School senior interested in pursuing a career in graphic arts and communications.

PETE & LAURA PANNIER SCOUTING SCHOLARSHIP

Awarded to a Marietta High School graduate involved in Scouting (preferably an Eagle Scout) who will attend a four-year accredited college.

EDWIN V. PUGH MEMORIAL SCHOLARSHIP TRUST

Awarded to a Marietta High School graduate who has excelled in history and/or government.

MELISSA ANN WECKBACKER MEMORIAL SCHOLARSHIP

Awarded to Fort Frye graduates planning to enroll in post-secondary education the fall after graduation and meet certain criteria established by the selection committee.

LISA MARIE WESEL MEMORIAL SCHOLARSHIP FUND

Established to provide tuition assistance for families with a financial need who have children attending St. Mary's School.

ADMINISTRATIVE FUNDS

Administrative funds provide support for the ongoing operation of Marietta Community Foundation.

THE ROBERT E. KIRKBRIDGE BOARD OF GOVERNORS' ENDOWMENT FUND

Funds to be used for the purpose of providing financial resources for Marietta Community Foundation operations and to ensure that the Foundation never needs to assess an administrative fee on any of its other Funds.

BUILDERS AND SPECIAL PROJECT FUNDS

Builders Funds are small funds that are slowly growing to a size sufficient to establish a traditional Fund at the Foundation. Special Project Funds are short-term assets held for a specific purpose.

4-H OF WASHINGTON COUNTY YOUTH FUND

The 4-H of Washington County Youth Fund was established in 2007 to provide funding to support the mission of the Washington County 4-H Advisory Committee. Established in 2007 to provide funding for local scholars.

THE ESCAPE OF JANE FOUNDATION

Provides financial support for community education about the Underground Railroad.

FAITH BIBLE CHURCH RACHEL HINES MISSIONARY FUND

The Faith Bible Church Rachel Hines Missionary Fund was established in 2007 to facilitate funding a missionary trip by Rachel Hines or such other person or persons, should for any reason Miss Hines be unable to fulfill the mission.

Established in 1996 to finance and maintain the Harmar Mural Project.

Created in 2007 to provide funding to support operations as well as maintenance and upkeep at Hervida 4-H Camp located in northwestern Washington County, Ohio.

CHARITABLE FUND**

Was established in 2005 in the names of Elmer, Helen, Cheryl and Diane Juhola to support the charitable needs of Marietta, OH.

KROGER WETLAND FUND

Established to provide support for the preservation of the Kroger Wetland in Marietta, Ohio.

MARIETTA BAND BOOSTERS

Provides financial support for the instrumental music department in Marietta City Schools.

**MARIETTA NATURAL HISTORY
SOCIETY FUND**

GRANT REQUESTS MUST INCLUDE:

- 1) A completed application form (Call the office.)
- 2) An IRS letter of 501(c)3 determination
(If you have not yet been determined a tax-exempt organization, please include a copy of your application status.)
- 3) A list of board members
- 4) A one-page project budget
- 5) An organizational budget
- 6) Key staff members involved in this project and their qualifications
- 7) A narrative description — no more than 5 pages that includes:
 - a. Statement of Purpose —
What is the purpose of your project and what community issues does it address?
 - b. Project's Objectives —
Describe the goals, activities and timeline of your project.
 - c. Target Population —
Who will benefit from this project?
Estimate the number of people to be served and the amount of services they will receive.
 - d. Collaboration —
Are you collaborating with other agencies?
Please indicate which one(s) and describe the collaboration efforts. Include support letter if appropriate.
 - e. Future Plans —
Is this (or will it become) an ongoing project?
If "yes" please describe how you will support it in the future.
 - f. Evaluation —
Describe how you will assess and measure your project's success.
 - g. Background Information —
Background material on your organization's history and operations.

Except to carry out the expressed purpose of a fund, the Foundation does not usually make grants to:

- provide the principal source of support to an organization or project;
- individuals;
- reduce operating deficits;
- promote a religious belief;
- provide building and renovation expenses;
- private or fraternal organizations;
- multiple-year pledge campaigns or;
- political action or advocacy initiatives.

In order for the Allocations Committee to consider a proposal, a Grant Application must be completed and signed by an authorized official of your organization.

Once an agency or organization's grant has been approved, we ask they begin work on the funded project or program within six months of the approval date.
